السلام عليكم

As informed earlier the PALPA Executive Committee has submitted the Working Agreement to the Management on 30th March 2009. The Association and its members are being governed undemocratically/arbitrarily by Admin Orders/Circulars for almost a decade.

The Association had requested the Management to pay an interim relief, which could be merged in the mutually agreed amount on conclusion of the Article-II of the Working Agreement.

The suggested 70 hours guaranteed payment as an interim has been linked with FDTLs upto the limit of ANO, which obviously is not acceptable to the Executive Committee. The Executive Committee has agreed on giving WAIVERS on certain flights in addition to the existing WAIVERS, to which the MD does not agree.

Inspite of the Executive Committee's best efforts and numerous meetings with MD and/or his representatives, a stage has come when the Management is not at all willing to agree on any thing, which could diffuse the prevalent impasse and stalemate.

With this background, the Executive Committee has decided that our full cooperation and unconditional support has not been amply acknowledged by the Management.

WITH IMMEDIATE EFFECT, THE MEMBERS ARE THEREFORE REQUESTED NOT TO ACCEPT ANY FLIGHT WITHOUT 12 HOURS NOTICE IN WRITING AND SHOULD DIRECT THE PLANNING & SCHEDULING DEPARTMENT TO KEEP THEM OFF FOR 10 DAYS IN A MONTH, AS BOTH FALL IN THE AMBIT OF THEIR ENTITLEMENT. THIS SHALL STAY ENFORCED TILL THE NEXT COMMUNICATION FROM THE EXECUTIVE COMMITTEE.
