PALPA-PODF ELECTIONS February 2012- February 2014 & JOINT AGM

In the 14th Annual General Body Meeting of the PODF Trust held on 7th May 2011, it was decided that their next Election process followed by AGM shall be held with PALPA Elections February 2012- February 2014. This decision was taken due to the following reasons:-

1. Poor turnout of membership during PODF Elections.
2. Insufficient quorum (Number of times, the AGM was postponed due to lack of quorum).
3. To curtail expenses of elections of both PALPA & PODF.
4. Reduce hassle to Election Committee to conduct two Elections separately.
5. Voters of PALPA & PODF are the same; hence the turn out for PODF will be the same as that of PALPA which is by the grace of God always above 95%.

On the request of PODF Board of Trustees, the PALPA Executive Committee acceded to their request and both Elections have been planned simultaneously.

The Election Committee for Karachi, Lahore & Islamabad under the Chairmanship of Capt. (Rtd.) Ashfaq Hussain shall be the same for both PALPA & PODF. The Election Committee as per PALPA Constitution and PODF Bye-laws will ensure that the procedures, rules and regulations during election process are followed.

The Chairman Election Committee has issued instructions as per PALPA Constitution and PODF Bye-Laws, as it is for the first time that PALPA & PODF Elections are being held together, the said instructions are attached herewith for your compliance signed by the Chairman of the Election Committee February 2012- February 2014.

ELECTION PROCEDURE

It is indeed an honour for me and all my Election Committee Members to conduct PALPA & PODF Elections February 2012- February 2014 together for the first time. To manage both the Election procedures simultaneously, some changes in the Elections schedule are required; with it following instructions are to be followed.


The procedure for Elections as per Chapter-VI, Article-I of PALPA Constitution and Clause 32 of PODF Bye-Laws shall be followed.

Candidates should be eligible to contest the Elections for both PALPA & PODF i.e. should be members in good standing of PALPA and should not be liable to disqualification under clause 3.3.3. of PALPA Constitution and Clause 24 of PODF Bye-Laws.

The following instructions/changes are as per PALPA Constitution and PODF Bye-Laws. These instructions and changes are to be followed in letter and spirit to make this procedure a success.

Changes in the schedule/dates of both the Elections (PODF & PALPA).

- Voting/Polling will start with effect from Wednesday the 18th January 2012 from 1000 hrs to 1700 hrs.
- Voting/Polling will end on Friday the 17th February 2012 at 1200hrs.
- Ballot Box retrieval from Islamabad & Lahore on Friday the 17th February 2012 by the first available flight.
- One Ballot Box each will be placed in Karachi, Islamabad & Lahore.
- Voting Forms will be of different colours.
 - ❖ For PODF it will be on their letter head (White)
 - ❖ For PALPA Active Pilots, it will be Green.
 - ❖ For PALPA Retired Pilots, it will be Pink.
- Annual General Meeting of PALPA & PODF shall be held on Saturday the 18th February 2012 AT 12:00 A.M.
- Election Results will be announced on Saturday the 18th February 2012 at about 1800 hrs.
