Currently, we have two broad categories of membership i.e. Transferable and Non Transferable at a price tag of Rs. 1,300,000/- and Rs. 850,000/- respectively. However, for PALPA we have developed two proposals one being transferable and other being Non Transferable which you will find extremely attractive and affordable.

NON TRANSFERABLE

1) Category of Membership:

Non Transferable except to spouse/children refer #4 below)

2) Price:

a) Rs. 01 Million for corporate membership. However, recognizing the status of PALPA being a Not for Profit Organization, this fee shall be totally waived provided that Thirty Five (35) applications with the requisite fee are submitted within the stipulated time period of 60 days after signing of the final proposal by both the parties. In case the target of Thirty Five (35) applications is not achieved, then this special package will not hold good.

(b) 1) Upfront Payment:- Each member of PALPA will pay a total membership fee of Rs. 425,000/- (as opposed to Rs. 850,000 which is being charged to other individual members for Non Transferable membership) upfront along with the membership application.

3) Entitlement of Facilities:-

All available facilities of the Club for Members + Spouse + all children under the age of 21 (first family members) as per rules.

4) Duration:- Life Time

Membership will be transferable to one of first family members any time during or after the life time of the Member by paying the prevailing transfer fee as approved by RPGCC.

5) Admission and Approval Criteria:

As per the application rules, regulations and discretion of RPGCC as well as the confirmation of membership from PALPA.

6) Relationship/Liability:-

After admission, the entire membership relations and liability would be strictly between the Club Member and RPGCC. PALPA will not be financially or otherwise liable for the conduct and actions of its members who would avail this plan.

7) Monthly Fixed Fee:-

Currently Rs. 3,300/- for the couple and Rs. 500/- and Rs. 2,000/- for each child aged 5-18 years and 18-21 years respectively subject to change from time to time and as applicable on other members of RPGCC according to the prevailing rules and regulations.

8) Validity of offer:-

Members of PALPA who would submit their complete application along with the respective upfront fee within two months after signing of the final proposal by both the parties.

9) Total No. of Seats:-

Maximum 70 on first come served basis subject to meeting the prescribed admission criteria of RPGCC within the time period of validity of the offer.

The PALPA members after acquiring this membership may transfer it to Premier membership by paying the difference.

TRANSFERABLE:-

1) Category of Membership:-

Transferable (refer # 4 below)

2) Price

a) Rs. 01 Million for corporate membership. However, recognizing the status of PALPA being a Not for Profit Organization, this fee shall be totally waived provided that Thirty Five (35) applications with the requisite fee are submitted within the stipulated time period of 60 days after signing of the final proposal by both the parties. In case the target of thirty five (35) applications is not achieved, then this special package will not hold good.

b) 1) Upfront Payment:- Each member of PALPA will pay a total membership fee of Rs. 425,000/- (Rupees four hundred and twenty thousand) (as opposed to Rs. 130,000/- which is being charged to other individual members for transferable membership) upfront along with the membership application.

3) Entitlement of faculties:-

All available facilities of the Club for Members + Spouse + all children under the age of 21 (first family members) as per rules.

4) Life Time:-

Membership will be transferable to one of first family members any time during or after the life time of the Member by paying the prevailing transfer fee as approved by RPGCC.

OR

After five years, it may be transferred to a third with the approval of RPGCC. The difference in price will be divided equally between the seller and RPGCC after deducting Rs. 425,000/- and the prevailing transfer fee. The two deductions will be given to the seller and RPGCC respectively.

5) Admission and Approval Criteria:-

As per the applicable rules, regulations and discretion of RPGCC as well as the confirmation of membership from PALPA.

6) Relationship/Liability:-

After admission, the entire membership relationship and liability would be strictly between the Club Member and RPGCC. PALPA will not be financially or otherwise liable for the conduct and actions of its members who would avail this plan.

7) Monthly Fixed Fee:-

Currently Rs. 6,500/- for the couple and maximum three children between the ages of five to twenty one years of age. Subject to change from time to time and as applicable on other members of RPGCC according to the prevailing rules and regulations.

8) Validity of offer:-

Members of PALPA who would submit their complete application along with the respective upfront fee within two months after signing of the final proposal by both the parties.

9) Total No. of Seats:-

Maximum 70 on first come first served basis subject to meeting the prescribed admission criteria of RPGCC within the time period of validity of other offer.
