UPDATE REGARDING PENSION LIFE CERTIFICATE REQUIREMENTS.

Dear PALPA Members, السلام عليكم

June 19, 2026.

This is to inform all PALPA members that PIA Holding Company Limited (PIAHCL) has issued Notification No. PIA-HCL/PENSION/2026/05 dated 18 June 2026 regarding the submission of Life Certificates by eligible pensioners. **(Copy attached)**

According to the aforesaid notification, all eligible pensioners of PIACL who ceased employment on or before 30th September 2023 are required to undertake biometric verification twice each year, **during the months of March and September**, at the bank branch where their pension account is maintained.

Members who have already completed the biometric verification and submitted the requisite Life Certificate issued by their respective banks are acknowledged as compliance and are not required to take any further action at this stage.

Members who have not yet completed the required biometric verification are requested to visit their respective bank branches and obtain/submit the following documents:

- 1. Life Certificate / Verification Receipt issued by the respective bank branch, containing:**
 - o Complete Bank Account Details
 - o IBAN Number
- 2. Copy of Valid Pension Card issued by PIACL.**
- 3. Copy of Valid CNIC.**

PALPA members are further informed that during the recent meeting held with CEO PIAHCL, it was agreed that a separate dedicated email address for pension-related matters would be established to facilitate pensioners and streamline correspondence. All members are advised to comply with the above requirements at the earliest to ensure continuity of pension payments and avoid any inconvenience.

NOTIFICATION

PROVISION OF LIFE CERTIFICATES BY PIAC ELIGIBLE PENSIONERS.

- Pursuant to the Finance Division-Govt. of Pakistan Notification No. 12(9) –Reg.6/2012 dated Jan 06, 2021 & State Bank of Pakistan (SBP) Circular Letter BC&CPD No.01 of 2021 dated Feb 01, 2021; all eligible Pensioners of PIACL who ceased employment on or before 30th September 2023 are required to undertake biometric verification at their respective Bank branches, where the pensioners are maintaining their accounts, twice in a year in the months of March & September.
- PIAHCL acknowledges the compliance by those eligible pensioners who have already completed biometric verification and submitted the requisite Life Certificates issued by their respective banks.
- All other respected pensioners who have yet not under-taken the due biometric verifications are requested to visit their respective bank branches and submit the followings.
 - i. Certificates/ Receipts issue by respective banks' branches containing Complete Bank Account Details & IBAN Number.
 - ii. Copy of valid Pension Card issued by PIACL.
 - iii. Copy of valid CNIC.
